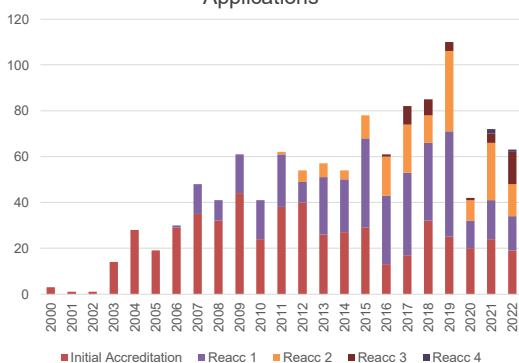


INTRODUCTION

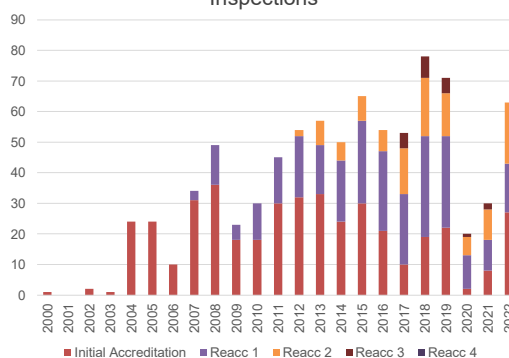

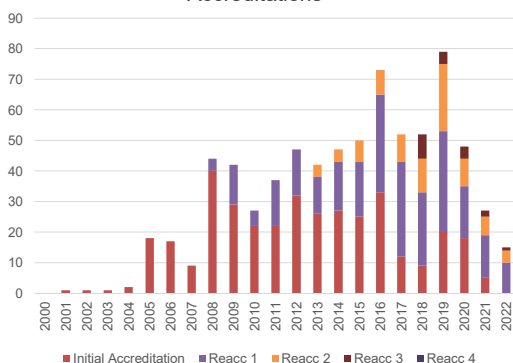

Remote Inspections

The development of different inspection processes has allowed JACIE to adapt to the specific situation of each centre with respect to COVID-19 with a greater flexibility. Although on-site inspections remain the mainstay of the inspections, remote inspections allow for a better contingency planning and improve the resilience at times of uncertainty.
